

# External: Children 8-16 years: Rules of use bouldering hall Fiesch

#### The Fiesch bouldering hall is unsupervised and under video surveillance.

Children between the ages of 8 and 16 can enter the Fiesch bouldering hall if their parents sign a declaration of consent. The child must be informed about the behaviour and prohibitions and must behave accordingly.

### Behaviour and prohibitions for children and young people aged 8-16

- 1. Children and young people aged 8-14 must always be accompanied by an adult supervisor. For safety and space reasons, children under the age of 8 are not permitted in the hall.
- **2.** the bouldering hall is not a playground. Children must behave in an orderly and disciplined manner.
- 3. Playing and running is prohibited in the entire bouldering hall.

#### Entry/Exit

- 1. both the SportCard and the single entry (QR code) are personal and nontransferable. When entering the hall, it is necessary for each person to scan their own card or QR code individually at the reader, even if several people enter at the same time.
- 2. Guest groups of the Sport Resort Fiesch always have priority.
- **3.** The following steps must be observed when leaving the bouldering hall:
  - a. The main entrance door must be closed.
  - b. The lights must be switched off if there are no other people in the hall.

### Voraussetzungen für die Nutzung der Halle

- 1. climbing is only permitted in climbing finches or clean indoor shoes (barefoot or in socks is prohibited).
- 2. Street shoes must be removed at the entrance.
- **3.** Magnesia should be used sparingly and only for climbing.
- **4.** Eating and drinking is prohibited in the halls.
- **5.** In the event of wilful damage or soiling of the facility, any damage must be borne by the person responsible.
- 6. There is a general ban on drugs, smoking and alcohol in the bouldering hall.



## Secuity

- 1. A maximum of 22 people may be in the entire bouldering hall at the same time, of which a maximum of 12 people may be actively climbing, distributed over a maximum of 6 people per hall.
- **2.** The fall protection areas must be kept clear at all times and it must be ensured that there are no obstacles in the way.
- **3.** In the event of an accident, you are responsible for calling 144 for help. It is therefore recommended that you always have a telephone with you.
- **4.** Handles and steps can twist under load and, in the worst case, break. Every person is aware of this risk and accepts responsibility.
- 5. Inform the staff of any defects in the bouldering facility.
