Important information for your visit to the rope park:

- Insurance is the responsibility of the user
- Participation in the instructions for using the park is obligatory for every participant
- Children under 11 years only when accompanied by an adult
- Children between 11 and 14 years only under the supervision of an adult
- Young people under 16 years of age require a declaration of consent from a parent or guardian
- **Minimum size is 1.30m**
- **Max. Body weight 120 kg**
- Recommended length of stay: 2.5 to maximum 3 hours
- Good footwear and clothing adapted to the weather is recommended

Safety:

- The Swiss Seilpark Fiesch is equipped with the «LockD Clip» System. This system reliably ensures that the climber cannot detach himself from the belay. Only one of the two communicating karabiners can be opened at once.
- Objects that pose a danger to other people (mobile phones, cameras, jewellery, rucksacks, etc.) must not be carried.
- Long hair must be tied together
